Also, please pass our invitation, info and attachments on to others who may be interested. Spaces in the showcase are limited to 160 players. Last year we had players on a waiting list—so do not delay!

Why should you play? First, by being invited you have been identified by us (and/or other coaches) as a player with the potential to play in college. ***Last year, over 100 Division 2, Division 3 and junior college head and assistant coaches attended this showcase.*** Information about you will be included in the **“Coaches’ Packet”** which will be available to each coach in attendance (and by mail to coaches upon request). However, there are some restrictions regarding Division 1 college coaches attending during this time period. Also, keep in mind that all coaches talk to each other, so word of your performance could travel farther than you think.

Want proof? Hundreds of former showcase participants have gone on to play Division 3 college basketball... The Division 2 scholarship schools have also benefited from our showcases—Joelle Martin (a 2 time All-American at Merrimack College) plays professionally in Italy. Lindsey Roche, Molly Griffiths and Kelly Meredith are at Assumption, Bria Tiro at LeMoyne, and Lauren Boivin at New Haven. Other former showcase participants have gone on to play Division 1 college basketball at including Caroline Stewart at BU and Taryn Johnson for Fairfield. From 2007 we have Cerie Mosgrove at UMass Amherst, Jackie Lyons and Denise Beliveau at UNH and Jenny Bandi at the Air Force Academy. From prior years we have Elaine McCants at Louisiana Tech, Sarah Bratton at St. Francis, Monique Lee at Quinnipiac, Brittany Engle at Marist, Stephanie Geehan at Fairfield, Kayliegh Scannell at Niagara, and Quiana Copeland at Northeastern.
